MERIT WISE RESULT OF CANDIDATES WHO HAVE BEEN SELECTED TO BE ENGAGED AS GENERAL COUNSELLORS IN HIGH COURT LEGAL SERVICES COMMITTEE PURELY ON CONTRACT BASIS FOR A PERIOD OF SIX MONTHS WHICH MAY BE EXTENDED FROM TIME TO TIME ON THE BASIS OF THEIR PERFORMANCE ALONGWITH WAITING LIST OF THE CANDIDATES FOR THE AFORE-SAID POST.
