Government of Haryana vide notification No.22/149/2015-1GSIII dated 01.04.2016 deleted all the provisions with regard to providing of reservation to Special Backward Classes.

Hon'ble Division Bench of Punjab and Haryana High Court, Chandigarh vide orders dated 12.04.2016 has dismissed the aforesaid CWP No.9132 of 2015 as infructuous.
