Hon'ble the Acting Chief Justice has been pleased to order that during ensuing spell of Dussehra Vacations, First Anticipatory Bail Applications, Cases relating to Life and Liberty (Protection matter of Runaway Couples) and 'any other Urgent Matter' as may be permitted by Hon'ble the Senior most Vacation Judge through Registry; will be entertained on 23.10.2023, 25.10.2023, 26.10.2023 and 27.10.2023.

Habeas Corpus Petitions will also be entertained from **22.10.2023 to 29.10.2023**.

Request for listing the case for the same day or next Court working day in case of First Anticipatory Bail Applications and Protection matters of Runaway Couples as well as taking up of 'any other Urgent Matter' including Division Bench matters, if any, will be made before Hon'ble the Senior most Vacation Judge available on the date mentioned only on Court Working days.
- 3.
