3. All types of matters (whether freshly instituted or applications in pending matters) will be accepted for filing in the DRR Section during Summer Vacations from 31.05.2021 to 25.06.2021.

However, For listing of the matters except mentioned at point no. 2, mentioning can be made through 'Online Mentioning' web-portal available on the website of Hon'ble High Court from 9:00 A.M. to 9:30 A.M. only by specifically specifying the ground of urgency for hearing the matter during the Summer Vacation.

4. Keeping in view the Covid-19 situation, the number of cases to be listed before the Hon'ble Vacations Benches will be staggered in future dates for listing and the cases will be listed as per their registration number.

The Anticipatory Bails, Protection matters of Runaway Couples and Habeas Corpus Petitions will be given priority over all the other matters.

5. All the Advocate/Counsels are requested to give the following note below the index at the time of filing the case/application:-

"Whether mentioning has been made? If Yes, its mentioning ID No..
