

Terms & Conditions

1. The rates should be F.O.R. Sub Divisional Court Complex, Nangal and Bholath, inclusive of all taxes, levies, GST etc.
2. The article should be of good quality.
3. The minimum Technical Specifications and Warranty of the product should be as per **Annexure A.**
4. The make/company of the product should be mentioned clearly.
5. Payment will be made only after receipt of complete supply, installation and commissioning to the satisfaction of this High Court and no advance payment will be made in any case.
6. While sending quotation, the word "QUOTATION FOR MULTIMEDIA PROJECTORS WITH SCREEN" may be inscribed on the sealed envelope.
7. The Rate Contract will be for one year.
8. The vendor who will supply the items will give an undertaking that the rates offered are lowest possible for this purchase. In case it is proved at any stage that you have offered lower rates to anyone else for the same product and during the same period, the vendor will be liable to pay differential amount to the High Court and face termination of contract at the discretion of High Court without notice.
9. The quotations received after due date will not be considered.
10. High Court reserves its right to accept or reject any proposal without assigning any reason.
11. The High Court can terminate the contract at any time by giving one month notice.
12. Arbitration: If any question, difference or objection whatsoever shall arise, in any way connected with or arising out of this contract or the meaning or operation of any part thereof or the rights, duties or liabilities or either party than save in so far as the decision of any such matter is here in before provided for and has been so decided every such matter including whether its decision has been otherwise provided for and/or whether it has been finally decided accordingly in whether the contract should be terminated or has been rightly terminated in whole or part and as regards the rights and obligations of the parties as the result of such termination, shall be referred for arbitration to the Punjab & Haryana High court or any other officer/official appointed by him and his decision shall be final and binding and where the matter involves a claim of the amount if any awarded in such arbitration shall be recoverable in respect of the matters so referred.
