Re: INVITING SEALED QUOTATIONS FOR THE PROCUREMENT OF 2 NOS. OF 15 KVA ONLINE UPS WITHOUT BATTERIES AND WITH THE OPTION TO BUYBACK THE EXISTING UPS, FOR THE USE OF THIS COURT.

Sealed quotations are invited from the Open Market (Authorized vendors, within Tri-city) for the procurement of 2 nos. of 15 KVA Online UPS (without batteries) for the use of this Court, with the option to buy-back the existing 2 UPS (Sr. Nos. UL-A-15-069A and UL-A-15-069B, installed in the year 2014) on as it is basis, on or before 31.08.2023 upto 5:00 P.M. The specifications of the UPSs may be perused at Annexure-A.

Terms & Conditions:

1. The Sealed Proposals, addressed to THE REGISTRAR (COMPUTERIZATION), PUNJAB AND HARYANA HIGH COURT, SECTOR-1, CHANDIGARH' should reach in this office latest by 31.08.2023 upto 5:00 P.M. Any offer received thereafter will not be entertained. The word "Procurement of 2 nos. of 15 KVA Online UPS (without batteries)" should be clearly inscribed on the top of the sealed envelope containing the Proposal.
2. The rates should be F.O.R. High Court premises, inclusive of all taxes, levies, GST and installation etc.
3. The prices for buy-back of 2 nos. of existing UPS must be quoted separately.
4. The Buy-back of 2 nos. of existing UPS (Sr. Nos. UL-A-15-069A and UL-A-15-069B, installed in the year 2014) is optional.
5. The existing 2 nos. of UPS might be checked/ inspected during 23<sup>rd</sup> August, 2023 to 26<sup>th</sup> August, 2023 in Punjab and Haryana High Court, Sector-1, Chandigarh, during Court working hours i.e. 9:30 AM to 5:00 PM, in coordination with Sh. Vineet Kalia, Network Incharge, ASD Lab, PHHC (#9855070202, 0172-2718354).

6. The UPSs must be compatible with the existing 64 nos. of batteries available at Punjab and Haryana High Court, Chandigarh (Exide SMF batteries 12V x 42AH).
7. It is made clear here that merely quoting lowest rates will not entitle any offer for its acceptance rather decision with regard to the acceptance of the offer would be taken by the Hon'ble Computer Committee after weighing proposal in its entirety e.g. experience of the vendor in the field, ability to provide timely delivery of the product, qualification/experience of technical manpower to be deputed for installation and goodwill of the firm etc. The High Court reserves its right to reject any or all the quotations without assigning any reason.
8. The vendor concerned will depute well qualified and trained technical manpower to this High Court for the immediate attendance of complaints, if any, during warranty period.
9. The firm will provide basic preventive maintenance to the equipment every 3 months to ensure that the UPS remain in good working condition as the company finds it necessary for the long and proper functioning of the equipments.
10. Any question, dispute or difference arising under the contract, shall be referred to the Arbitrator, who shall be appointed by the Registrar General of this High Court. The award of the Arbitrator shall be final and binding on both the parties. The venue of the arbitration shall be Chandigarh. The proceedings will be conducted in accordance with the Arbitration and Conciliation Act, 1996 and the Rules made there under.
